RULES ON THE INTERNET USE for Liepāja University Residence Hall

Issued in accordance with Paragraph 2.4 of the Constitution of Liepāja University

- 1. The Rules on the Internet Use of Liepāja University, hereinafter LiepU, shall set out instructions on the use of the Internet, and the rights and responsibilities of the Internet users, while providing and using the access to the Internet in the Residence Hall.
- 2. LiepŪ wireless connection to the Internet shall be intended for carrying out assignments associated with the studies and the research work, giving an opportunity for the tenants to access various information resources portals, mail servers, letters, and so forth available on the Internet.
- 3. The wireless network connection point name for LiepU Residence Hall shall be "LiepU".
- The wireless network connection for the tenants of the Residence Hall shall be provided on a 24/7 basis.
- 5. LiepU shall not accept liability for providing the Internet, if a tenant of the Residence Hall uses unsuitable software, hardware, unsuitable environment, or the tenant has low computer literacy, and if interruptions to the Internet are caused by problems in operation of the Internet service provider.
- 6. If any problems associated with the Internet connection or use arise, LiepU shall ensure a consultation the consultations are held on business days at IT Service Lab of LiepU, in Liepāja, 14 Lielā Street, or via telephone 63407779.
- 7. LiepU, without the obligation of prior notice to a user, shall reserve the right to exercise control of the Internet data flow, including accounting of the most visited Web-sites, locking of the access to variety of information, information resources, and services on the Internet.
- 8. If any claim on distribution of harmful software from the Internet service provider or the lab of the Information Technology Security Incident Response Institution of the Republic of Latvia is received, LiepU, without the obligation of prior notice to a user, shall reserve the right to deny the access to the user for the Internet.
- 9. The wireless network connection shall not be used by the unauthorized persons who are present in the Residence Hall without a prior permission obtained from the Residence Hall Administrator.
- 10. LiepU shall have the rights to modify and amend these Rules unilaterally. When the Rules are modified or amended, LiepU shall carry out the repeated explanation and instruction concerning the Rules on the Internet Use for the tenants of the Residence Hall.
- 11. It shall not be allowed for the user to:
 - 11.1 distribute information, using the wireless network connection to the Internet, which may offend other person's honor and dignity, propagate violence, kindle national and ethnic hate, contains materials of pornographic nature, and is intended for hooligan or fraudulent purposes.
 - 11.2 send any illegal information prohibited by the effective laws and regulatory enactments of the Republic of Latvia.
 - 11.3 distribute information on the Internet, using any means which allow hiding the type and the point of connection (open proxy servers, and so forth).
 - 11.4 distribute useless information to the other Internet users, including:
 - 11.4.1 emails or spams which are sent in bulk, and without obtaining a prior agreement;
 - 11.4.2 emails where the volume of one email exceeds 30MB;
 - 11.4.3 emails which contain advertising and canvassing materials, commercial information and which contain any offending information (including rude and uncensored expressions), and materials of pornographic nature;
 - 11.4.4 information which is repeatedly sent to the Internet user who has already notified that do not want to receive such the information:
 - 11.4.5 use of non-existent return addresses.
 - 11.5 take unauthorized scan of IP addresses of any type and range.
 - 11.6 use of unauthorized methods for an attempt to access computers of other Internet users by using requisites of the other users or harmful software.
 - 11.7 obtain unauthorized access to the Internet resources, including:
 - 11.7.1 undertaking of the activities which cause interruptions to the normal operation of the Internet resources (Web servers, email servers and so forth);
 - 11.7.2 undertaking of the activities, deleting and modification of the information, in order to obtain unauthorized and privileged access to the Internet resources.
 - 11.8 use the network connection in order to create personal resources on the Internet, including creation of:

- 11.8.1 a personal email server;
- 11.8.2 an open proxy server;
- 11.8.3 a Web server.
- 11.9 perform bulk data upload and download, exceeding 5GB in total for a period of twenty-four hours.

12. It shall be the user's responsibility to:

- 12.1 observe the copyright on the information available on the Internet as provided by the Copyright Law, including sending, publishing, and displaying of the materials which are partly or fully protected by the copyright without an official permission obtained from the owner.
- 12.2 monitor personal hardware a computer, a smartphone, and so forth by carrying out scan for harmful software on a regular basis.
- 13. If the Rules Rules are not observed, LiepU shall reserve the rights to deny the access to the wireless network for a tenant of the Residence Hall.
